2. Release. The undersigned on behalf of himself or herself and his or her personal representatives, successors and assigns, forever discharges and releases the Company and its directors, officers, employees and agents of and from all actions, causes of action, suits, damages, judgments, executions, defaults, covenants, controversies, agreements, provisions, counsel fees, cost, claims and demands whatsoever, known or unknown, which are capable of being asserted or could be asserted, resulting from, based upon or relating to the undersigned's participation in the rides. This release includes all and any future personal injury, property loss or other damages relating to and involving any and all claims not now known to the undersigned but which may later develop, including the effects or consequences thereof and all causes of action therefore (including those for negligence, breach of contract, tort or strict liability) relating to the undersigned's participation in the rides or club activities.
3. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of Maryland
